As part of a national organization of 120 chapters of Assistance League, our mission is to serve our local community with cutting-edge programs to ensure those most in need are served directly.

To help enrich the lives of thousands of school children, families and seniors in Los Gatos, Saratoga, Campbell, and West San Jose our 115 dedicated volunteers donated 19,000 hours of service to provide essential needs to many currently underserved and in need of a helping hand. As an all volunteer nonprofit with no overhead 88% of every dollar spent is returned to the community.

In Our First 15 Years We:

- Served 110,000 clients
- Contributed 250,000 hours of volunteer service
- Returned **\$1 Million** to our local community

Accomplishments in 2017-2018:

- 807 students in 36 primary grade classrooms were read to monthly by our 42 Literacy Program volunteers. 3000 books were donated to classroom libraries and each child received three books to take home and keep
- 32 kindergarteners and first graders tutored through our Literacy Plus Program
- 820 dictionaries distributed to third graders in 9 schools
- 342 students in 21 schools received a warm new jacket and new shoes
- 165 partial scholarships awarded to 5th & 6th grade students to attend Science Camp
- 1500 K-5 students participated in three hands on STEAM engineering projects
- 145 middle school students grew vegetables to eat in their school garden
- 280 new moms and their babies received quilt bundles with layettes, toys and diapers to help them with a better start as a family
- 4,900 lunches prepared during the year to serve seniors at the Saratoga Adult Day Care Center

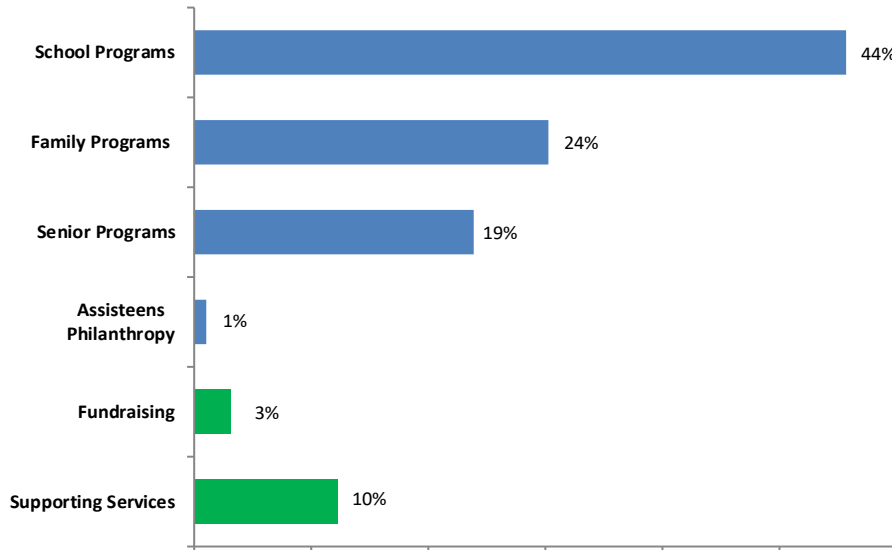

FINANCIALS for FYE 2017-18

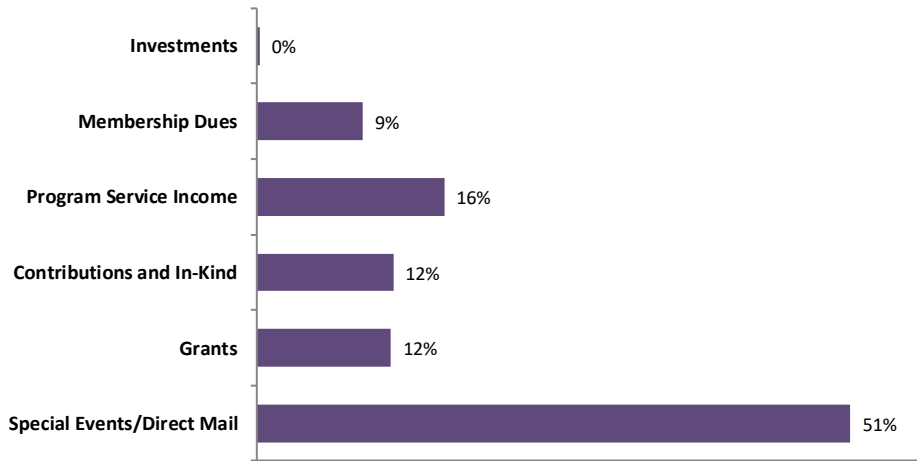
