As part of a national organization of 120 chapters of Assistance League, our mission is to serve our local community with cutting-edge programs to ensure those most in need are served directly.

Last year our 110 dedicated volunteers donated nearly 15,000 hours of service to enrich the lives of thousands of school children, families, and seniors in Los Gatos, Saratoga, Monte Sereno, Campbell, and San Jose. As an all volunteer non-profit with no paid staff and minimal overhead, 87% of every dollar we spend is returned to the community.

In Our First 17 Years We:

- Served 130,000 clients
- Contributed 285,000 hours of volunteer service
- Returned **\$1.2 Million** to our local community

Accomplishments in 2019-20:

- 749 students in 32 primary grade classrooms were read to monthly by our 42 Literacy Program volunteers. 1516 books were donated to classroom libraries and each child received three books to take home and keep
- 160 tutoring sessions for 20 kindergarteners and first graders through our Literacy Plus Program
- A new Inquiry and Innovation Day provided 800 third graders with a science lesson and a copy of Ada Lace on the Case easy-reader book to keep
- 622 students in 13 schools received a warm jacket, new shoes, hygiene kit, and uniforms
- 101 partial scholarships awarded to 5th & 6th grade students to attend Science Camp
- 4000 K-5 students participated in three hands-on STEAM engineering projects
- 304 new moms and their babies received quilt bundles with layettes, toys and diapers to help them with a better start as a family
- 2,360 lunches prepared during the year to serve seniors at the Saratoga Adult Day Care Center

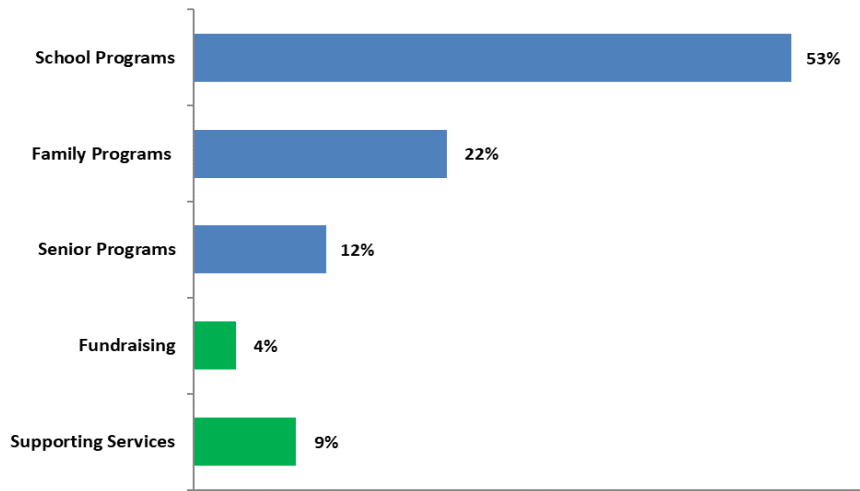

FINANCIALS for FYE 2019-20

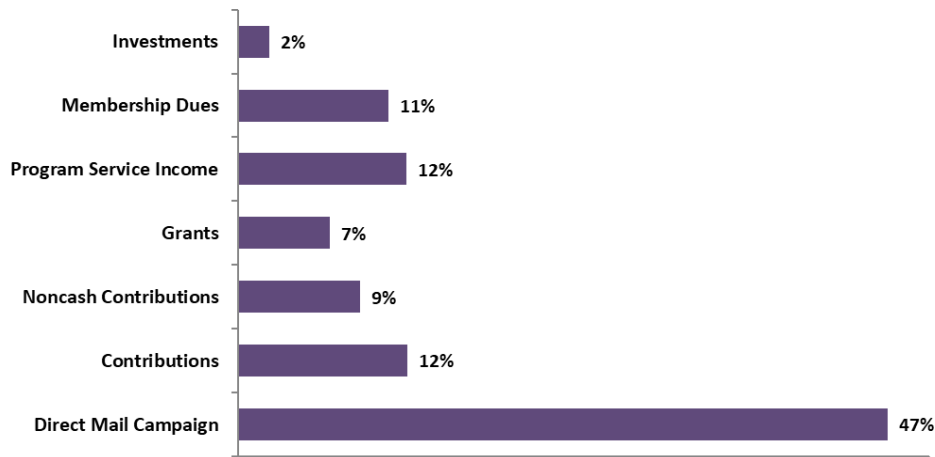
